approved CO-OP in football for the 2024-25 SY. BOE was introduced to the idea of Miami offering HS Cross Country for the 2024-25 SY.

- b. Principal Report- E-Hallpass has been a great success thus far. Newsela access has been given to all teachers. All teachers have a Google Classroom. Monday school is being offered to students with attendance issues. Senior action plans have been created. The A+ program students are on track with their hours an expectations. Current enrollment for Elem (PK-6) 101 students and JH/HS (7-12) 77 students. Total enrollment 178 students.
- c. Safety Get the Lead Out- We will get fountains and fixtures that need to be replaced taken care of and then we will retest.

## H. Superintendent/Notes-

One furnace in the old gym has quit working and the other is going out. We can add air conditioning through the furnace units. To replace both heat only it will be \$4,800.00 each to replace both with heat and air conditioning it will be \$8,900.00 each. New outdoor bleachers came in today. Our APR has been competitive in the conference. This year we had our first APR in a while and out of 558 schools we are 77<sup>th</sup>. Our growth is also above average for math.
